- 一、國家理論科學研究中心數學組(以下簡稱本中心或中心)為加強與國外著名研究中心及 大學之學術交流、積極參與國際學術活動。故鼓勵國內研究優異或具研究潛力之學 者、博士後研究人員及學生,赴國外作短期研究訪問,及參加特定重要國際數學會 議,特訂定本要點。
- 二、本辦法適用之對象含計畫主持人、中心相關人員與延攬人才、獲推薦參與中心計畫之 相關領域系所或研究機構之學生、博士後研究員,及國內相關領域學者等。
- 三、有意申請本補助者,請於出國四週前(出國期間超過一個月者請於八週前)填附件申請表,並附活動相關資料、個人基本資料及指導教授推薦信(助理教授級以上免附推薦信),學生請另附成績單。
- 四、補助案由相關研究主題主持人初審,中心主任複審。通過複審者給予補助,項目可包括執行交流計劃之交通費、生活費及註冊費。補助金額由中心主任核定,以不超過國科會國外差旅費標準支付範圍為準則。若補助金額超過15萬元、或是補助期間超過一個月者,需經執行委員會同意。
- 五、本辦法經執行委員會通過,自發布日實施。

National Center for Theoretical Sciences Mathematics Division (NCTS) Guidelines for Travel Support for International Destinations

- 1. To enhance academic exchanges with research centers and universities abroad, the National Center for Theoretical Sciences Mathematics Division (hereinafter referred to as the NCTS) encourages outstanding or promising domestic researchers, postdoctoral researchers, and students to conduct short-term academic visits overseas and participate in important major international mathematics conferences. Thus, the NCTS establishes these guidelines.
- 2. The eligible applicants under these guidelines include project principal investigators, researchers associated with the NCTS, students and postdoctoral fellows who participate in the NCTS-related programs, and domestic scholars in related fields.
- 3. Those intending to apply for the travel support, please submit the application form (attached) at least 4 weeks prior to the scheduled departure date (or eight weeks if the overseas stay exceeds one month). The application should include relevant event information, application form, and a recommendation letter from the advisor (recommendation letters are not required for applicants of assistant professor level or above). Students should also attach the academic transcripts.
- 4. The applications will be reviewed first by the NCTS Program Chair of the relevant research topic program and then by the Center director. Approved applicants will receive subsidies, which may cover travel expenses, living expenses, and registration fees for taking part in the exchange program. The subsidy amount will be approved by the Center director and must not exceed the reimbursement standards set by the National Science and Technology Council (NSTC). For subsidy amounts exceeding NT\$150,000 or periods exceeding one month, approval from the executive committee is required.
- 5. These guidelines and their revisions must be approved by the executive committee and shall be implemented from the date of announcement.
